



During the month ended 26th September 2025, the Fund NAV increased by 0.97% to US\$ 113.44 (previous month: US\$ 112.35), with reported portfolio yield (post-leverage) of 7.23% p.a. (previous month: 7.61%), and average duration of 0.72 years (previous month: 1.01 years).


