

Silverdale Fund of Funds (Fixed Income) is an open-ended US dollar denominated enhanced-returns fund investing in other fixed income funds. During the week ended 29th April 2022, the Fund NAV decreased by 1.59% to US\$ 75.01 (previous week: US\$ 76.23), as against Bloomberg Multiverse Index which decreased by 1.00% while Bloomberg EM Hard Currency Index which decreased by 1.20%. The Fund had actual portfolio yield (post-leverage) of 10.11% per annum (previous week: 9.64% p.a.), with average duration of 2.96 years (previous week: 2.76 years).


