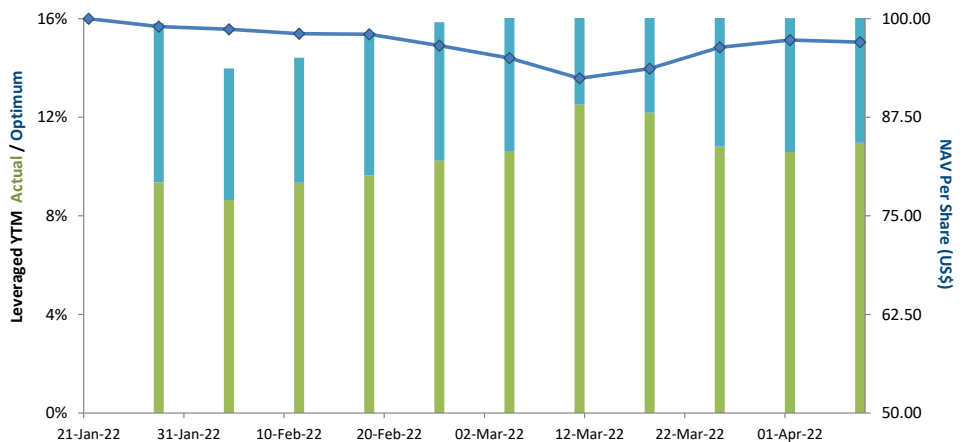

Silverdale Fixed Maturity Fund 2026 is a leveraged short duration bond fund maturing around 3rd April 2026. During the week ended 8th April 2022, the Fund NAV decreased by 0.27% to US\$ 97.02 (previous week: US\$ 97.28) with actual portfolio yield (post-leverage) at 10.96% per annum (previous week: 10.59%) and average duration of 2.99 years (previous week: 3.02). The fund portfolio is still under construction.

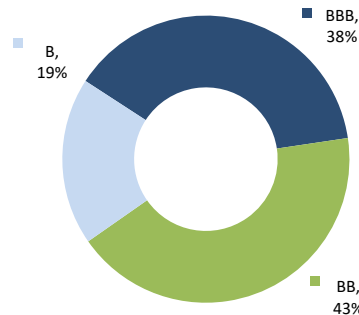
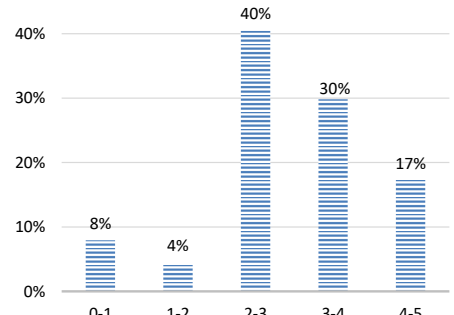

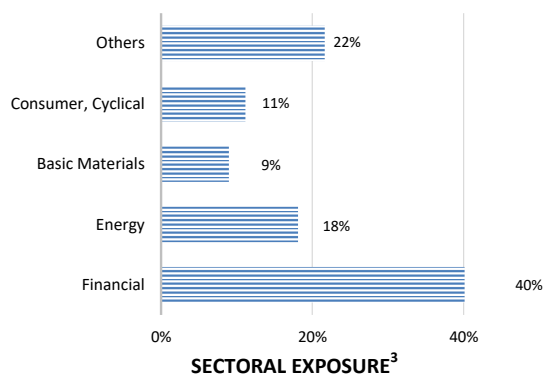
