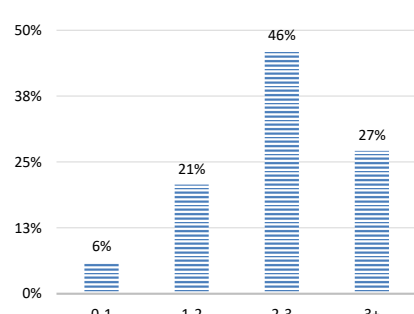
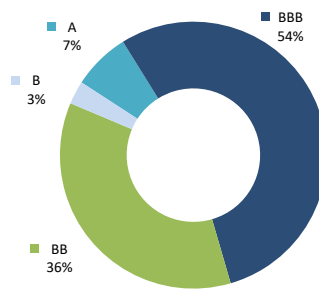
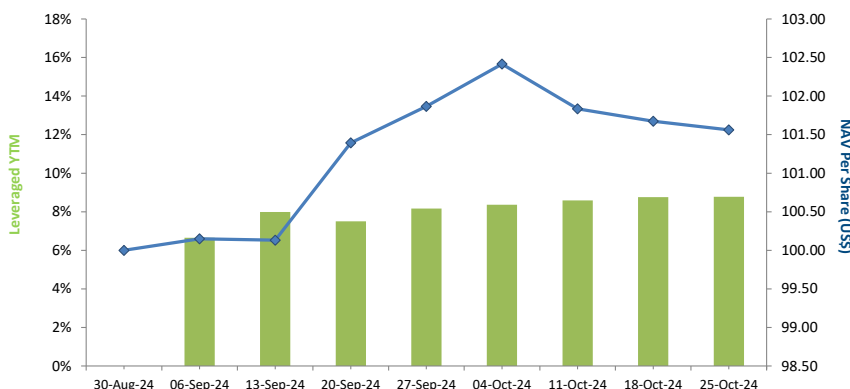

Silverdale Fixed Maturity Fund August 2024 is an enhanced return fixed tenure bond fund maturing March 2028. During the month ended 25th October 2024, the Fund NAV decreased by 0.30% to Cum-Dividend NAV of US\$ 101.56 (previous month: US\$ 101.87). The Fund paid US\$ 3.00 per share of dividend resulting in Ex-Dividend NAV of US\$ 98.56, with portfolio yield (post-leverage) of 8.77% p.a. (previous month: 8.17% p.a.), with average duration of 2.52 years (previous month: 2.55 years). The portfolio is still under construction.

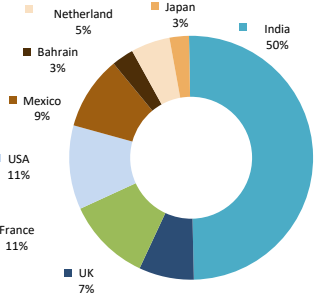
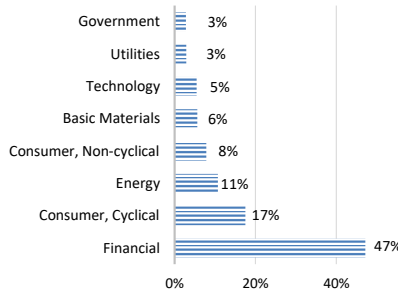

PORTFOLIO UPDATE

During the month ended 25th October 2024, the Fund NAV decreased by 0.30% as against a decrease of 0.09% for the Bloomberg Emerging Market USD Corp and Quasi 1-3 Yr Index. The decrease in NAV was mainly due to Indian, Mexican and French credits, while it was partly offset by British and Dutch credits. Sectorially, Financial, Energy and Consumer Non-Cyclical were the key detractors, while it was partly offset by Basic Material. The decrease in NAV was partly offset by the mark-to-market gains from interest-rate swaps (IRS) as market priced in fewer rate cuts.

DIVIDEND UPDATE

The Fund declared its First Dividend post roll-over, of US\$3.00 per share on Distributing Class shares. All investors holding Distribution Class shares on Friday, 25th October 2024 (Dividend Record Date) have been paid dividend.
