PORTFOLIO UPDATE

During the month ended February 2025, the Fund NAV increased by 1.43% as against an increase of 0.86% for Bloomberg EM USD Corp and Quasi 1-3yr Index. The increase in NAV was primarily led by Indian, Mexican and British credits. Sectorially, Financial, Basic Materials and Energy sectors were the key contributors.
