PORTFOLIO UPDATE

During the month ended 28th February 2025, the Fund NAV increased by 1.62% as against an increase of 0.86% for the Bloomberg EM USD Corp and Quasi 1-3yr Index. The increase in NAV was primarily led by Indian, Mexican and American credits. Sectorially, Financial, Energy, and Consumer Cyclical were the key contributors. The increase in NAV was partly offset by mark-to-market losses from interest-rate swaps (IRS) as the market priced in more rate cuts.
